Article I - Name

The name of this corporation is D&M LAWN SERVICE, INC.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

The purpose of this corporation shall be to engage in the business of lawn care and to transact or to engage in any lawful business not prohibited by the laws of the State of Florida or the United States of America.

Article IV - Capital Stock
