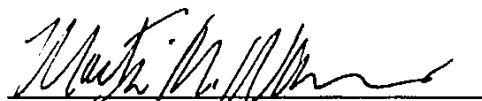

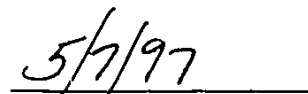
ARTICLE VI AMENDMENT

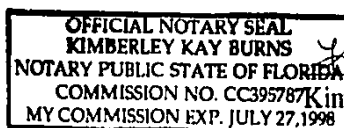
