## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HOWARTH, KEYS, MCCRORY & ASSOCIATES, INC.

Pursuant to Sections 607.1006 and 621.13 of the Florida Statutes, the undersigned corporation, HOWARTH, KEYS, MCCRORY & ASSOCIATES, INC. (the "Corporation"), a Florida corporation organized and existing under and by virtue of the laws of the State of Florida, adopts the following Articles of Amendment to Articles of Incorporation.

- 1. <u>Corporate Name</u>. The name of the Corporation set forth in its original Articles of Incorporation is Howarth, Keys, McCrory & Associates, Inc.
- 2. <u>Amendment Adopted</u>. The amendment adopted provides for a change of the name of the Corporation.
- 3. <u>Text of Amendment.</u> Article I of the Articles of Incorporation is hereby amended by deleting such Article in its entirety and substituting in lieu of such Article the following new Article I, which reads as follows:
