ARTICLES OF INCORPORATION  
OF  
DECORATING SERVICES-DESIGN RESOURCE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopt the following articles of incorporation:

ARTICLE I

NAME

The name of the corporation is DECORATING SERVICES-DESIGN RESOURCE, INC.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The corporation is formed to provide interior design wholesalesale supplies and fabrication services and to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

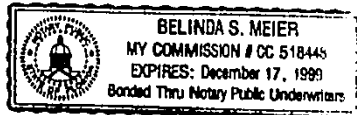


