**ARTICLES OF INCORPORATION**

The undersigned incorporators, for the purpose of forming a corporation under the Laws of the State of Florida, hereby adopt the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of this corporation shall be Full-On Painting Products, Inc.

**ARTICLE II**

**PURPOSE**

This corporation is formed for the purpose of conducting business and for any and all other such purposes as may be lawful.

**ARTICLE III**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 8606 Cattail Drive, Tampa, Florida 33637.

**ARTICLE IV**

**SHARES**

This corporation is authorized to issue and have outstanding at any one time up to ONE HUNDRED (100) shares of common stock bearing a par value of ONE dollar (\$1).

**ARTICLE V**

**AMENDMENT OF THESE ARTICLES**

These Articles may be amended at any time only by a majority vote of the shareholders of this corporation. No other vote is necessary for such amendments.

**ARTICLE VI**

**INDEMNIFICATION**

This corporation shall indemnify its directors, officers, employees, and agents to the fullest extent allowable under the Laws of the State of Florida.

**ARTICLE VII**  
**MANDATORY DISTRIBUTIONS**

This corporation must authorize distributions to its shareholders annually in an amount needed for the shareholders to pay taxes due by virtue of this corporation filing Form 1120S with the Internal Revenue Service, or electing to be treated as an S corporation under the United States Revenue code, so long as such distributions are otherwise legally permissible. Should this corporation fail to make a distribution under this Article because it is unable to legally make such distribution, this corporation shall make the distribution as soon as it is legally able to make the distribution, in full or in part, and shall increase the required distribution at the rate of twelve percent per annum.

**ARTICLE VIII**  
**INITIAL DIRECTORS**

The initial board of directors of this corporation shall be comprised of Michael Robert Sadowski and Paul Anthony Jamison, both of 8606 Cattail Drive, Tampa, Florida 33637.

**ARTICLE IX**  
**INITIAL OFFICERS**

The initial President of this corporation shall be Michael Robert Sadowski of 8606 Cattail Drive, Tampa, Florida. 33637. The initial Secretary/Treasurer of this corporation shall be Paul Anthony Jamison of 8606 Cattail Drive, Tampa, Florida. 33637.

**INITIAL REGISTERED AGENT**


Michael Robert Sadowski of 8606 Cattail Drive, Tampa, Florida. 33637, shall serve as the initial registered agent of this corporation.
