ARTICLES OF INCORPORATION

OF

FRUECHT, INC.

The undersigned, acting as the Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is Fruecht, Inc.

ARTICLE II

The period of duration of the corporation is perpetual.

The purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and Florida, including but limited to construction and general contracting services.

ARTICLE IV

Authorized shares

Number: The aggregate number of shares that the corporation

Voting Rights: Of the 2000 Class A Common Shares authorized,
