


ARTICLES OF INCORPORATION

OF

EFFECTIVE DATE 05/08/97

ARTICLE I - NAME

The name of this Corporation is NME RAMZI CORP.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.
