ARTICLE I - NAME OF CORPORATION

ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

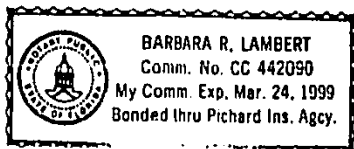
