Name

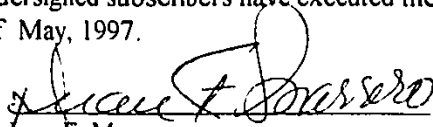

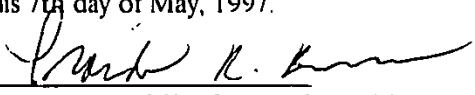
