# ARTICLES OF INCORPORATION

#### ARTICLE I -- NAME

The name of this corporation is Brothers Concrete, Inc.

#### ARTICLE II--DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
