ARTICLE I

The name of the corporation is LATIN AMERICA GAMING CORP. (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 1 Callo, 1y2 Avenida, Edificio Bolivar, No. 219, San Pedro Sula, Honduras, C.A.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

ARTICLE IV

The Corporation shall hold a special meeting of shareholders only:
