ARTICLES OF INCORPORATION FOR CARIBBEAN KIDS, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Accorporation to the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is CARIBBEAN KIDS, INC.
