ARTICLES OF INCORPORATION

<u>OF</u>

ARC X-RAY IMAGING, INC.

The undersigned, acting as Incorporator of a corporation under the Florida Business corporation Act, adopts the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is ARC X-RAY IMAGING, INC.
- 2. PRINCIPAL OFFICE/ MAILING ADDRESS: The street address of the initial principal office and mailing address is 8420 Ulmerton Road, #436, Largo, Florida 33771.
- 3. SHARES: The corporation is authorized to issue one thousand (1,000) shares of One Dollar par value common stock. The shares shall be of a single class.
- shareholder PRE-EMPTIVE of this RIGHTS: Each 4. corporation shall have the first right to purchase shares securities convertible into shares of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number shares he holds at the time of issue bears to the total number of shares by share holder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms

and conditions of the issue of shares, and inviting him to exercise his pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within within thirty (30) days of receipt of notice from the corporation.

- 7. CAPITAL STRUCTURE: The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than ten persons. Stocks shall be issued and transferable only to natural persons who are not non-resident aliens.
- 8. CORPORATION'S RIGHT OF FIRST REFUSAL ON STOCK TRANSFERS:

 No stockholder shall have the right to sell, assign,
 pledge, encumber, transfer, or otherwise dispose of any of the
 shares of the corporation without first offering such shares for
 sale to the corporation at the net asset value thereof. Such

offer shall be in writing, signed by the stockholder; shall be sent by registered or certified mail to the corporation at its principal place of business; and shall be open for acceptance by the corporation for a period of thirty days from the date of mailing. If the corporation fails or refuses within such period to make satisfactory arrangements for the purchase of such shares, the stockholder shall have the right to dispose of his shares as he may see fit.

On the death of any stockholder, the corporation shall have the right to purchase all shares owned by such stockholder immediately prior to his death on the terms set forth above, and this provision shall be binding on the executor, administrator, or personal representative of each stockholder.

Each share certificate issued by the corporation shall have printed or stamped thereon the following legend: "These shares are held subject to certain transfer restrictions imposed by the Articles of Incorporation. A copy of such Articles is on file at the principal office of the corporation."
