

ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is SWISS ACCESS, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the State of Florida and the United States of America. This shall include, but not be limited to: sales, service, importing, exporting manufacturing, research and development of telecommunication equipment, components, parts, supplies and materials; resale of wholesale electronic components and all other related activities.

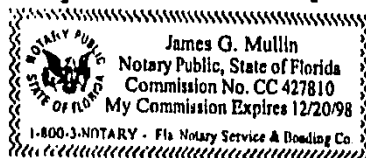
