ARTICLE ONE

The name of the corporation is **PROFIT-PAK DISTRIBUTING, INC.** The principal address of the corporation is: 2700 W. Atlantic Boulevard, Suite 200-29, Pompano Beach, Florida 33069.

The period of its duration is perpetual.

ARTICLE THREE

ARTICLE FIVE

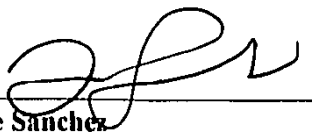
The corporation will not commence business until it has received for the issuance of shares consideration of the value of \$1,000.00 consisting of money, labor done or property actually received.
