

ARTICLE ONE. NAME

The name of the corporation is STARSTRUCK ENTERTAINMENT, INC.

ARTICLE TWO. PURPOSE

ARTICLE NINE. AMENDMENT



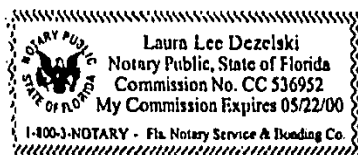


