ARTICLE I

CORPORATE NAME

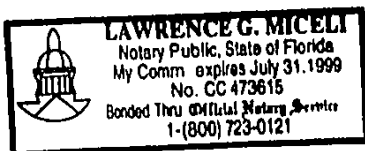
