ARTICLES OF INCORPORATION OF UNITY FUNERAL CHAPELS, INC

Article I - Name

The name of this corporation is UNITY FUNERAL CHAPELS, INC.

Article II - Duration

This corporation shall commence on the date of these Articles into perpetuity.

Article III - Purpose

This corporation is organized for the purpose of providing funeral and mortuary services and arrangements as well as transacting any and all other lawful busyness including the power:

- a) To have perpetual succession by its corporate name
- To sue and be sued, complain and defend in its corporate name in all actions or proceedings.
- c) To have a corporate seal, which my be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
- d) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property or any interest therein, wherever situated.
- e) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
- f) To lend money to, and as credit to assist, its officers and employees in accordance with Florida Statute 607.141.
- g) To purchase, take receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in an with, shares or other interest in, or obligation of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.
- h) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and othet obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.
- To lend money for its corporate purposes, invest and reinvest its funds, and take
 and hold real and personal property as security for the payment of funds so loaned
 or invested.

- To conduct its business, carry on its operations, and have offices and exercise the powers granted by law within or without this state.
- To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.
- To make and alter bylaws, not inconsistent with these Articles of Incorporation

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorate share thereof, (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
