



3. This Amendment was adopted by unanimous vote of all the shareholders of Buccaneer's Roost Development Corporation, on the 26th day of June 1997.




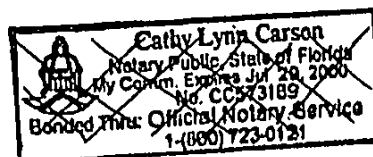
