In compliance with the requirements of F.S. Chapter § 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I.
CORPORATE NAME**

The name of the corporation ("Corporation") is R&B Contractors, Inc.

**ARTICLE II.
EFFECTIVE DATE**

These Articles of Incorporation shall be effective upon approval by the Secretary of State of the State of Florida.

**ARTICLE III.
CORPORATE ADDRESS**

The street address of the principal office of the Corporation is 821 NW 1st Terrace, Cape Coral, FL 33993.

**ARTICLE IV.
CORPORATE STOCK**

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

**ARTICLE V.

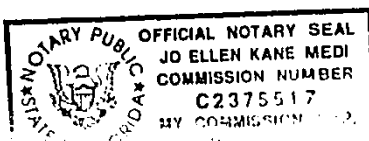

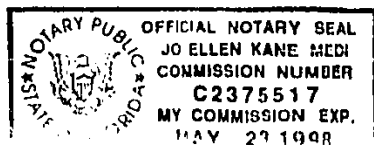
