

ARTICLE I

NAME

The name of this corporation shall be: **PROFESSIONAL BUSINESS SERVICES OF
THE TREASURE COAST, INC.**

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV

CAPITAL STOCK

1) This corporation is authorized to issue **TWO THOUSAND (2,000)** shares of Class A stock and **TWO THOUSAND (2,000)** shares of Class B stock. These classes of stock are equal in preferences, limitations, and relative rights except that Class B stock shall not have any voting rights.


