# ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of this Corporation is TOUCH SURVEYS, INC.

# ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

# ARTICLE III - PURPOSE
