The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I CORPORATE NAME

The name of the Corporation is G.M.A. TRAVEL, INC., located at 2488 West 64 Place, Hisland Gardens, FL 33016.

ARTICLE II INITIAL REGISTERED OFFICE
