**ARTICLES OF INCORPORATION**

The undersigned, acting as the incorporator of **INFRASTRUCTURE DEVELOPMENT GROUP, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation is: Infrastructure Development Group, Inc.

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal business office and mailing address of the corporation is 208 South Gardenia, Tampa, Florida 33609.

**ARTICLE III. INITIAL BOARD OF DIRECTORS**
