To Whom It May Concern:

Enclosed please find a signed 2006 Corporate Annual Report for Mi Ranchito Meat Market Inc.

Per correspondence from and telephone conversations with representatives from the Florida Division of Corporations (FDOS), it has come to our attention that the 2006 Annual Report, which we submitted with our payment of \$158.75 in late March 2006, was inadvertently left unsigned and, therefore, not accepted by the FDOS. However, the FDOS did keep and cash our check on April 6, 2006 for \$158.75. Therefore, this timely payment should be applied to our account in payment of the 2006 fee. Also, per instructions from the FDOS, enclosed is an additional check in the amount of \$400.00 representing payment of the penalty for late filing of the 2006 Annual Report.

However, we respectfully request an abatement of this penalty. Though mailed timely, the 2006 Annual Report was deemed to be late by the FDOS because, unfortunately, it was inadvertently submitted unsigned. But because we thought we had mailed in the properly signed Annual Report and because our original payment of the fee was cashed by the FDOS, we assumed the subsequent notice we received from the FDOS requesting an Annual Report was sent in error (or crossed in the mail). Also, some confusion was added by the fact that, while the owners and management of Mi Ranchito speak English, it is not our first language and it was only after consultation with our accountants regarding this issue that we realized our error. We did not willfully neglect our responsibility to timely submit a Report and have taken steps to ensure it does not happen in the future. Therefore, we respectfully request the penalty be abated and request a refund of the \$400.00 payment we've enclosed.

Thank you for your prompt attention to this request.
