



ARTICLES OF INCORPORATION
OF
COMPUTER & ELECTRONIC SHOWCASE, INC.

The undersigned, acting as incorporators to these Articles of Incorporation, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I
NAME AND ADDRESS

The name of the corporation is: COMPUTER & ELECTRONIC SHOWCASE, INC. The physical address of the corporation is 4505 Park Boulevard, Pinellas Park, Florida 33781. The mailing address of the corporation is P. O. Box 1685, Pinellas Park, Florida 33780.

ARTICLE II
NATURE OF BUSINESS

The purpose of this corporation is to engage in any activities or businesses permitted under the laws of the United States and the laws of the State of Florida.

ARTICLE III
CAPITAL STOCK

The corporation is authorized to issue seven thousand five hundred (7,500) shares, all of one class, at a par value of One Dollar (\$1.00) per share.

ARTICLE IV
TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V
REGISTERED OFFICE AND REGISTERED AGENT
