Article I - Name

The name of this corporation is Chubasco, Inc.

Article II - Purpose

The corporation is organized for the purpose of owning and operating a fishing vessel business and for the purpose of transacting any or all lawful business.

Article III - Capital Stock

This corporation is authorized to issue three thousand (3,000) shares of one dollar (\$1.00) par value common stock, which shall be designated "common shares".

Article IV - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article V - Initial Registered Office and Agent

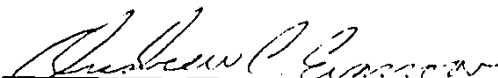
Article VI - Initial Board of directors
