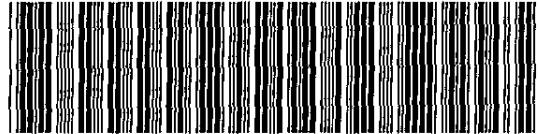



The undersigned, acting in his capacity as the President of Simulation Training Applications, Inc. (the "Corporation"), a Florida corporation, on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation.

ARTICLE III


The amendment to the Articles of Incorporation reflected in Article II hereof was approved by the shareholders. The number of votes cast for the amendment was sufficient for approval.
