Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Alliance Bank are hereby amended as follows:

Article I of the Articles of Incorporation is hereby amended by deleting the FIRST: text thereof in its entirety and substituting the following in lieu thereof:

The name of the corporation shall be CNL Bank and its initial place of business shall be at 455 South Orange Avenue, in the City of Orlando, in the County of Orange and State of Florida.
