Please find enclosed an application for corporate reinstatement for Swander Enterprises, Inc, FEI #59-3498076. We included corporate filing fees for the years 2002 and 2003 totaling \$300.00. We respectfully request abatement of all penalties and request immediate reinstatement of the corporation. We inadvertently did not file during these years for the following reasons:

- 1. We moved to a new location in November 2001 and have had trouble with our mail being forwarded due to the confusion of the city we are located in ie we are one block away from a Beverly Hills address and although our legal property description is Citrus Springs the post office at first recognized us as a Dunnellon address. We did not receive the corporate filing papers for 2002 or 2003.
- 2. Our former CPA became gravely ill and merged with four other CPA's to protect his interest. It seems as though our account was mishandled due to the illness and eventual death of our CPA and the confusion of a merger. We have had to pay other penalties associated with late or missed filings. In fact we did not know the corporation was dissolved until the state did a payroll audit on us. We then contacted the CPA to have consultation, he passed away during this time period and we consequently changed accountants.
