ARTICLE I - NAME

The name of this corporation is COMMUNICATION OPTIONS SOUTHERN REGION, INC. ~~(aka, COI)~~.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing with the date of execution and acknowledgement of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business including, but not limited to, telecommunication services.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100,000 shares of One Cent (\$0.01) par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every Shareholder, upon the sale for cash or any stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT


ARTICLE X - INDEMNIFICATION



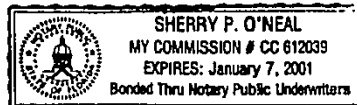


