

ARTICLES OF INCORPORATION MAIDA, GALLOWAY & NEAL, P.A.



The undersigned incorporators, each of whom is licensed and legally authorized to practice is law in the State of Florida, associate themselves with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopt the following articles of incorporation for the corporation:

ARTICLE I NAME

The name of the corporation is Maida, Galloway & Neal, P.A.

ARTICLE II PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is 300 East Park Avenue, Tallahassee, Florida 32301. The name of the initial registered agent of the corporation, located at that office is Thomas J. Maida.

ARTICLE III DURATION

The period of the corporation's duration shall be perpetual, or until dissolved on a vote of the shareholders as provided in these articles.

ARTICLE IV PURPOSE
