Please be advised that this letter is written in response to your letters of July 27 and 28 regarding Rockwell Pipe Supply, Inc. and Stripes Paving, Inc. Copies of these letters are attached for your review.

As we understand your letters of July 27 the Annual Report was filed but the filing fee of \$150.00 was missing for each account. The letters of July 28 state that the filing fee of \$150.00 has been received for each company, but that a balance of \$400.00 is due on each account for late filing.

In telephone conversations with your office prior to the filing of these reports Mr. Zalopany advised one of your agents that the reports were not received prior to the April 30 deadline. The agent advised Mr. Zalopany to send the report and the \$150.00 payment to the reinstatement department, which is what Mr. Zalopany did in good faith. Without the timely receipt of the reports Mr. Zalopany was unaware of his filing requirement or the substantial penalty associated with late filing.
