The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: PUBLICATION DISCOUNT INTERNATIONAL, INC. The principal office of the Corporation is 4511 Tower Pine Road, Orlando, Florida 32839.

Article 2. Duration. The duration of the Corporation is perpetual.
