ARTICLES OF AMENDMENT OF

**THE UNDERSIGNED**, CATHERINE COWART, M.D., being the President and Secretary, of HYDE PARK MEDICAL ASSOCIATES, INC., does hereby certify that the following Amendment to the Articles of Incorporation of HYDE PARK MEDICAL ASSOCIATES, INC. was approved by the Stockholders of said Corporation on the 5<sup>th</sup> day of December, 2001, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of HYDE PARK MEDICAL ASSOCIATES, INC. are hereby amended as follows:

1. Article I is hereby deleted and the following is inserted in lieu thereof:

ARTICLE I

1. The name of the Corporation shall be HYDE PARK MERGING MEDICAL ASSOCIATES, INC.

2. All amendments included herein were adopted December 5, 2001 pursuant to Section 607.1004, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.


