
ARTICLE VI - INITIAL OFFICER OF CORPORATION

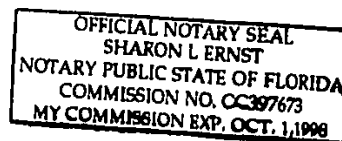


