ARTICLES OF INCORPORATION OF ASIAN QUALITY PRODUCTS. INC.

The undersigned, for the purpose of forming a corporation under the Plorida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE 1 - NAME

The name of the corporation is Asian Quality Products, Inc. The principal office is c/o Gustavo Echeverria at 1111 Crandon Blvd. #A-905 Key BIscayne, F1. 33149

ARTICLE 2 - DURATION

The term of existence of the corporation is perpetual.

ARTICLE 3 - PURPOSE
