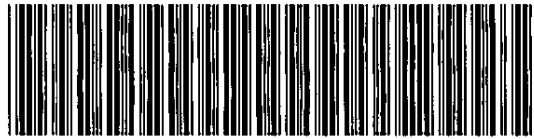


The undersigned, being all of the Directors and Shareholders of SK ASSOCIATES OF FLORIDA CORP., hereby certify that:
