NAME

The name of this corporation is: Panorama Brewing Company

ARTICLE 2

DURATION





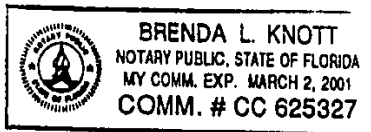
