ARTICLE I
NAME

The name of the corporation shall be: DE JESUS & ASSOCIATES, P. A.

ARTICLE II
PRINCIPAL OFFICE

SECTION 3. The President shall preside at all such meetings.

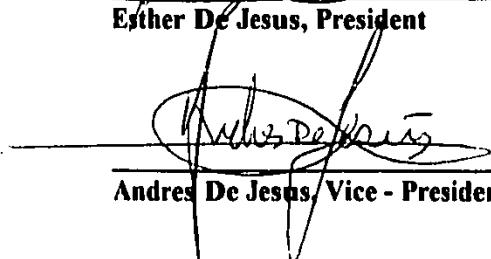
