ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF CHANDLER INVESTMENT COMPANY

The general nature of the business to be transacted by this corporation, or the objects or purposes of the corporation, shall be as follows:

- 1. to engage solely and specifically in the business of carrying on the general practice of real estate sales;
- 2. to own real and personal property necessary for the rendering of the above professional services; and
- 3. in general, to have and exercise all powers conferred by the laws of Florida upon professional service corporations, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

This corporation shall have perpetual existence.
