

**Article I**

*Name.* The name of this Corporation is D.O.E. CONSULTING, INC.

**Article II**

*Principal Office.* The address of the principal office of the Corporation is 2015 Bran Avenue, South Daytona, FL 32180.

**Article III**

*Duration.* The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

**Article IV**
