

The undersigned Incorporator to these Articles of Incorporation hereby forms a Professional Association under the laws of the State of Florida in accordance with the Florida Business Corporation Act.

ARTICLE I

CORPORATE NAME

The name of this Professional Association shall be:

ARTICLE II

TERM OF EXISTENCE

This Professional Association shall have perpetual existence.

ARTICLE III




