ARTICLES OF INCORPORATION

OF

TALLAHASSEE, FLORIDA

FLORIDA COIN EQUIPMENT, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name and address of the corporation is FLORIDA COIN EQUIPMENT, INC. 7050 N. W. 44th Street, #107, Lauderhill, FL 33319.

ARTICLE II. NATURE OF BUSINESS

The nature of the business and the objects and purposes to be transacted, promoted and carried on are to do any and all of the things necessary to conduct a business of operating coin laundry location(s). In addition, this corporation may do all these things as well as all of the following as fully and to the same extent as a natural person might or could do.

- 4. To sell, manage, improve, develop, assign, transfer, convey, lease, pledge or otherwise alienate or dispose of and to mortgage or otherwise encumber land, buildings, real property, chattels, real or other property of the company, real and personal.
- 5.
