ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of the corporation is G.E.R. AUTO REPAIR, INC..

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Secretary of State.

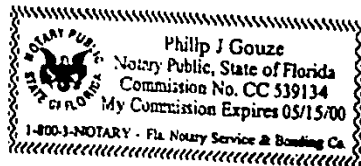
