

ARTICLES OF INCORPORATION
OF

The name of the corporation is THE ENCHANTED CLOSET, INC. The principle office and mailing address is:

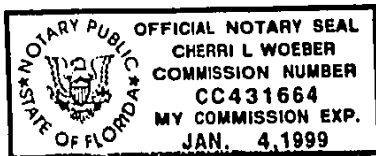


