ARTICLE I

The name of this Corporation shall be **AMERICAN GREEN LANDSCAPING, INC.**, and its initial mailing address shall be P.O. Box 2323, Sarasota, Florida 34230-2323. The initial address of the Corporation's principal office shall be 1349 W. University Parkway, Sarasota, Florida 34243.

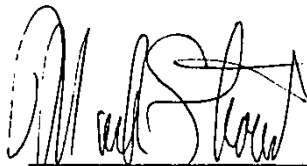

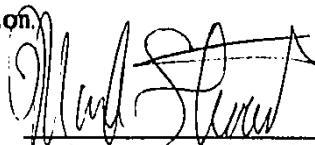
These Articles of Incorporation may be amended in the manner provided by law.
