To whom this may concern,

I have been in touch with your office and have spoke with Jane and Gary, (sorry, I was not given their last names), about my payment due on May 1st not being sent on time.

As I told your 2 representatives, I did not receive the forms this year until my payment was already late. The reason for this is that the original forms were sent to the wrong address from your offices the first time as I discovered after receiving the second set of documents.

As of October of 1999, the U.S. Post Office had all persons using a STE address to file paperwork and change their addresses to a PMB location, or they would refuse to deliver the mail. Because of this change in the law, I did not receive my first set of documents. I was informed by your representatives to send this letter explaining the situation along with my original fee of \$150.00. My business dealings are no longer sent to 3101 Vine St. and my revised business address under the new law is as it appears above:
