#### ARTICLES OF INCORPORATION

#### ARTICLE I - NAME:

The name of this corporation is: BOROSANA, INC., hereinafter referred to as the "Corporation".

#### ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

#### ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Wholesale/Retail Shoe business and for the purpose of transacting any or all other lawful business not inconsistent with the Laws of the State of Florida.

## ARTICLE IV - CAPITAL STOCK:
