The 1998 Annual Report was inadvertently never submitted by taxpayer's prior attorney. This was brought to Mr. Stevenson's attention when the second request was received.

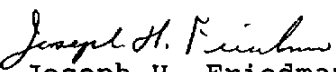
Check in the amount of \$150.00 is enclosed, covering the Annual Report for 1998.
